Implementation of the Corporate Transparency Act - *The Corporate Transpar*ency Act (CTA) represents the most significant reformation of the Bank Secrecy Act and related anti-money laundering rules since the US PATRIOT Act. Although the CTA is mainly focused on reporting of beneficial owner information (BOI) by corporations, limited liability companies, and partnerships, trusts and beneficiaries of trusts may also find themselves the subject of required disclosures related to BOI. With the reporting requirements under the CTA becoming effective January 1, 2024, now is the time for

wealth planning and tax practitioners to better understand these compliance obligations and gain knowledge of how and when to provide notice of reporting requirements, how to modify and update planning documents, and how the implementation of the CTA will impact the planning and privacy concerns of clients.
